Recommendation CM / Rec (2013) Committee of Ministers – 10 July 2013

- ► Gender equality is a prerequisite for the full enjoyment of human rights.
- Democracy and gender equality are interdependent and mutually reinforcing.





Political communication and gender equality: The Italian case



Different levels of legislation to guarantee equal access between genders in political communication and information programmes

- >AGCOM resolutions
- ➤ Resolutions applicable to the PSB
- ➤ Evolution in national law
- ➤ Self-regulation



Rules during non electoral periods

"Persons involved in free political transmissions must be identified ensuring, if possible,

equal opportunities between men and women"



Resolution 200/00/CSP (equal treatment in non-electoral periods)



RAI - the public service broadcaster

"Obligation to ensure, among other things, a balanced representation of genders in media"

Parliamentary Commission for the general guidance and supervision of broadcasting services: Regulations about political communication and equal access during electoral periods (the last dating January 2013)





RAI - the public service broadcaster

The draft of the new contract of service (recently approved by the Board of Directors of Rai, now awaiting the opinion of the Supervisory Board) endorse the changes already introduced to fight against gender discrimination.



... a new law ...

... expressly provides a change to law no. 28/2000 governing equal access to the media during election campaigns and requires compliance with the principle laid down in Article 51 of the Constitution,

for the promotion of equal opportunities between women and men in media


Law 215 /2012, "Measures to promote the rebalancing of gender representation on boards and in the joints of the local and regional councils . Provisions on equal opportunities in the composition of the selection committees in the public sector



... something new in going on ... Women and Media Code

April 2012

a committee of experts was set up for the adoption of a code of self-regulation on the use of the female image in the media


