IRIS Merlin database, the Audiovisual Law Information Wizard http://merlin.obs.coe.int/

As of 1 September 2020, IRIS Merlin included **8 743** short descriptive articles based solely on facts, with exact reference to **8 628** source documents (laws, decrees, court cases, etc.).

AVMSDatabase on the transposition of the Audiovisual Media Services Directive 2010/13/EU in all 28 EU Member States

The database contains searchable reference legal texts of national transpositions of the Directive in the 28 EU member states. It will be regularly updated to take account of amendments to national legislation.

A revamped version will be made public in June 2020, to take into account the implementation measures of the revised Audiovisual Media Services Directive 2018/1808.

LUMIERE

The process of importing the 2019 admissions data started in January 2020 is complete.

LUMIERE includes for the year **2019** admissions data in **33** Observatory member countries. This represents over **1.2** billion admissions for some **10** 000 feature films.

LUMIERE PRO (paying service)

LUMIERE PRO is an enhanced version of the LUMIERE database. It allows the Observatory and (due to copyright restrictions) a clearly defined group of clients (mainly public film bodies across Europe) to obtain annual title-by-title admission data on all European as well as **14 non-European markets** (**3 484 films** representing ca. **4 136 million admissions**). The service furthermore provides access to the statistical tools of the LUMIERE database.

LUMIERE VOD - The European film directory

The European film directory provides data on European films and their availability on-line in video-on-demand (VOD) services throughout the European Union. It contains data on over 35 000 European films offered 150 000 times on VOD. This data has been taken from 300 different VOD catalogues available in 28 European countries.

Available online, the Yearbook provides an overview of television, VOD, cinema and video in 41 countries, and includes some 400 tables and 39 country fact sheets.

The 2020/2021 edition of the Yearbook will be launched on 9 November 2020. Subscribers will already have access to over 200 files. More will be published until the end of December.

COVID-19 tracker

As of mid-March 2020 we have been tracking information on specific national measures aimed at supporting and guiding the audiovisual sector and to the cultural and creative industries in the 41 Member States of the European Audiovisual Observatory. These measures are collected in a downloadable EXCEL table updated regularly (click **here**).

So far the COVID Tracker has tracked 1 068 measures taken and registered 6 509 downloads.



Agreement with and participation in the Cannes Film Market

Further to the cancellation of the Cannes Film Market due to the COVID-19 crisis, the Observatory participated in the virtual Cannes Film Market instead which took place from 22-26 June 2020. As a consequence, this year the new edition of the publication FOCUS - World Film Market Trends (24th edition) was distributed electronically to the participants (virtual bag). The Observatory organised an event during the Marché du Film online. We produced a <u>documentary short on the effects of the pandemic on the audiovisual industries</u> by interviewing major stakeholders from each sector. A live chat with the interviewees followed the projection of the film. The Observatory Experts provided scene setting facts, figures and analysis in the film and on the panel. This event took place on Tuesday 23 June from 17.00 – 18.00.. The Observatory also had an online booth where contacts were made and our latest publications and databases were promoted.
